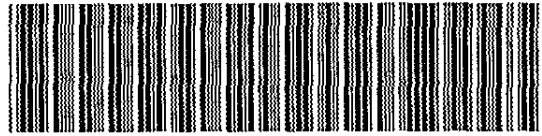

**ARTICLES OF INCORPORATION**

**FOR**

**RZ FLOOR COVERING, INC.**

The undersigned for the purposes of forming a corporation for profit under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is: RZ FLOOR COVERING, INC.

**ARTICLE II. DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III. PURPOSE**

The purpose of the corporation is to reenact any and all lawful business for which corporation may be incorporated under the Florida General Corporation Act.

**ARTICLE IV. CAPITAL STOCK**

This corporation is authorized to issue 10,000 shares of common stock with a par value of \$1.00 a share. The Board of Directors may dispose of the authorized by the unissued stock from time to time.
