**ARTICLES OF INCORPORATION
OF
RIP JOHNS CONCRETE, INC.**

ARTICLE I.

NAME

The name of this corporation is Rip Johns Concrete, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The initial principal office address of this corporation is 105 Francis Church Road, Palatka, Florida 32177, and the initial mailing address is the same.

ARTICLE III.

COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV.

CAPITAL STOCK

This corporation is authorized to issue ten thousand (10,000) shares of common stock with a par value of one cent (\$.01) per share. Without action by the shareholders, any or all of the authorized shares may be issued by this corporation from time to time for such consideration as may be fixed by the Board of Directors of this corporation.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation in the State of Florida is 105 Francis Church Road, Palatka, Florida 32177, and the name of the initial registered agent of this corporation at that address is Eugene C. Johns. The Board of Directors may, from time to time, change the registered agent or move the registered office to any other address in Florida.

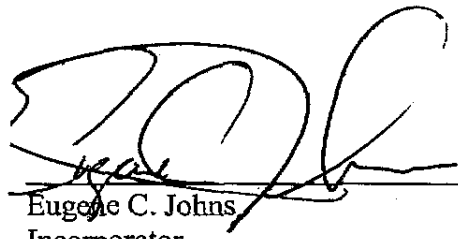

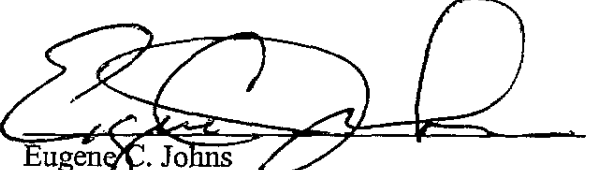
