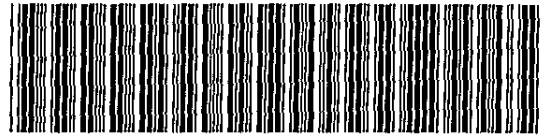

ARTICLES OF INCORPORATION

OF

ADVANCED ROBOTIC DIGITAL SYSTEMS, INC.

The undersigned, **JEFFREY T. VONU**, being a natural person, for the purpose of forming a corporation pursuant to the requirements contained in **Chapter 607, Florida Statutes**, the "**Florida Business Corporation Act**", does hereby act as the sole Incorporator in adopting, and delivering to the **Florida Department of State** for filing, the following described "**Articles of Incorporation**"; and, hereinafter referred to as the "**Articles**".

ARTICLE I

CORPORATE NAME

The name of the corporation is **ADVANCED ROBOTIC DIGITAL SYSTEMS, INC.**;
and, hereinafter referred to as the "**Corporation**".
