Pursuant to the authority of the Florida Business Corporation Act, the undersigned hereby adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE 1  
NAME OF THE CORPORATION**

The name of the Corporation is JSA ENTERPRISE OF LABELLE, INC.

**ARTICLE 2  
AMENDMENT**

Article 6 of the Articles of Incorporation of the Corporation shall be amended to read in its entirety as follows:

**ARTICLE 6  
DIRECTORS**

*The business and the affairs of this corporation shall be managed by a Board of Directors which shall be elected by the shareholders and serve as provided in the Bylaws. The number of the members of the Board of Directors may either be increased or decreased from time to time by the Bylaws, but shall never be less than one (1).*

**ARTICLE 3
