ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a professional association under the Professional Services Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name and Duration

The name of this professional association is CHARLES V. WILSON, M.D., P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these Articles are filed by the Secretary of State.
