Conflict of Interest



Amendment

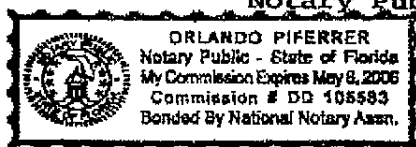


