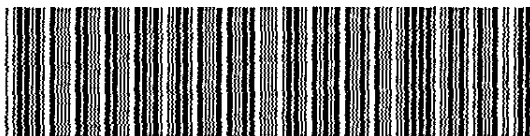

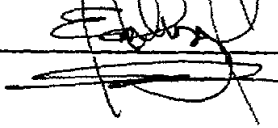
ARTICLE XI

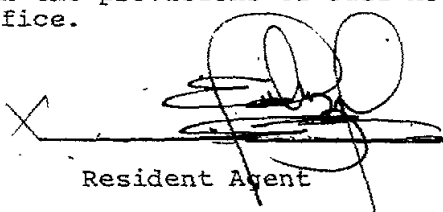
