**ARTICLES OF INCORPORATION**

I, the undersigned Incorporator and Subscriber, being a natural person competent to contract, hereby organize and incorporate under the laws of the State of Florida a corporation for profit as follows:

**ARTICLE I - NAME OF CORPORATION**

The name of this Corporation shall be CRNT - I, Inc., having as its initial corporate mailing address at: c/o Steven L. Daniels, Esq., Arnstein & Lehr, 515 No. Flagler Drive, Sixth Floor, West Palm Beach, Florida 33401.

**ARTICLE II - DURATION**

This corporation shall be perpetual in existence unless sooner dissolved according to law.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of acquiring, developing, leasing and selling real estate, and transacting any or all lawful business which corporations may transact pursuant to Chapter 607, Florida Statutes.

**ARTICLE IV - CAPITAL STOCK**

The authorized capital stock of the corporation shall be One Thousand (1,000) shares common stock.

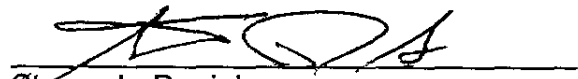
**ARTICLE VIII - MANAGEMENT OF CORPORATION BY SHAREHOLDERS**

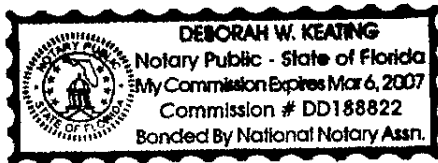
