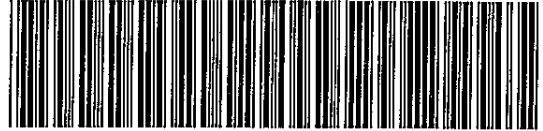

ARTICLES OF INCORPORATION

OF

Article I

The name of this corporation is Precision Placement, Inc.

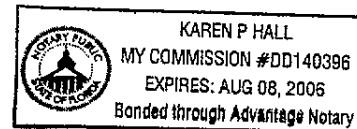


