# ARTICLES OF INCORPORATION

OF

#### FLINT INVESTMENTS, INC.

# ARTICLE I - NAME:

The name of this corporation is: FLINT INVESTMENTS, INC., hereinafter referred to as the "Corporation".

# ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing por the filing of the Articles of Incorporation with the Department of State.
