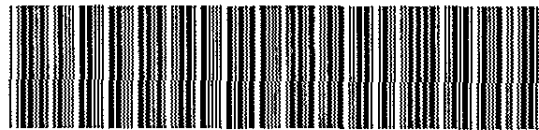

ARTICLE XI – SMALL BUSINESS CORPORATION & SECTION 1244 STOCK



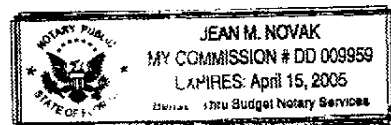
