The undersigned subscriber is a natural person competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

# **ARTICLE 1 - NAME**

The name of the corporation is Jamie Noble, Inc.

# ARTICLE 2 - TERM OF EXISTENCE

The corporation shall have perpetual existence.

#### ARTICLE 3 - PURPOSE OF CORPORATION

The corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

# **ARTICLE 4 - PRINCIPAL OFFICE**

#### ARTICLE 5 - CORPORATE CAPITALIZATION
