



ARTICLES OF INCORPORATION

OF

DOLPHIN PROPERTY MANAGEMENT, INC.



I. NAME

The name of the corporation is DOLPHIN PROPERTY MANAGEMENT, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.
