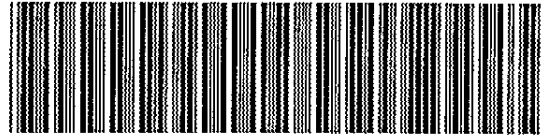

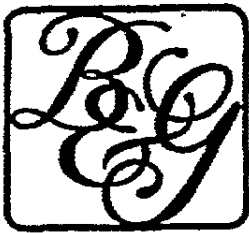

I. NAME

The name of the corporation is DOLPHIN PROPERTY MANAGEMENT, INC.

X. AMENDMENTS

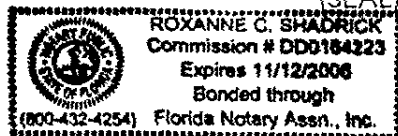
