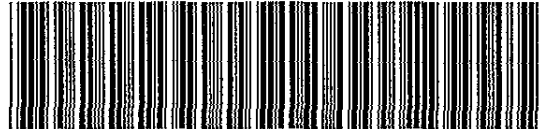



The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE XII - ACTION BY DIRECTORS WITHOUT A MEETING


