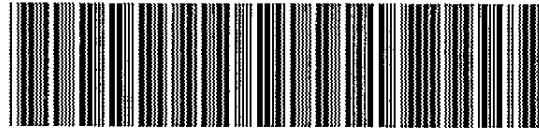

ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is VITTLE'S CONCESSIONS, INC., and the principal address and principal place of business is 5858 96<sup>TH</sup> CIRCLE NORTH, PINELLAS PARK, FLORIDA 33782.

ARTICLE II - REGISTERED OFFICE AND AGENT
