



ARTICLES OF INCORPORATION

OF

PHONECIAN CORPORATION

ARTICLE I

NAME

The name of the corporation is PHONECIAN CORPORATION



ARTICLE II

ADDRESS

The mailing address and principal office of the corporation is 328 Crandon Boulevard, Suite 221-C, Key Biscayne, Florida 33149.

ARTICLE III

PURPOSE

The corporation shall be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended and supplemented.

ARTICLE IV

DURATION

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

ARTICLE V

POWERS

The corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapter 607, Florida Statutes, as amended and supplemented.

ARTICLE VI

CAPITAL STOCK

The total number of shares of all classes of stock which the Corporation shall have authority to issue is One Thousand (1,000), with each such share having a par value of One Dollar (\$1.00) for an aggregate par value of One Thousand Dollars (\$1,000). The stock of the Corporation shall be issued in two (2) classes: Class A and Class B with each class of stock representing fifty percent (50%) of the equity. Class A and Class B shares shall have identical dividend rights. The board of directors may determine the preferences, limitations and relative rights of all classes of stock.

ARTICLE VII

DIRECTOR

The corporation shall have one director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the corporation, but shall never be less than one (1). The name and address of the initial director of the corporation is:
