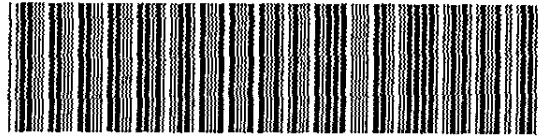



OF



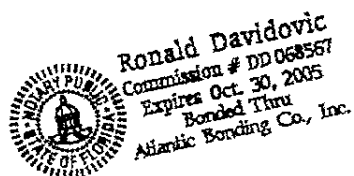
