### ARTICLES OF INCORPORATION OF SKY KING FIREWORKS OF DAYTONA BEACH, INC.

#### ARTICLE I - NAME

The name of this corporation is Sky King Fireworks of Daytona Beach, Inc.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
