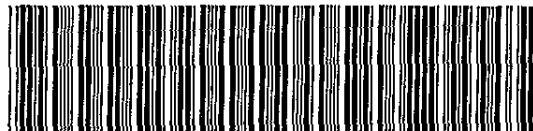

**ARTICLE I**

The name of this corporation is **Sunshine Facilities Maintenance, Inc.**

**ARTICLE II**

The duration of this corporation is perpetual.

**ARTICLE III**

The general purposes for which this corporation is organized are:

The number of directors constituting the initial Board of Directors of the corporation is 2 (two). The name and address of each person who is to serve as a member of the initial Board of Directors is:



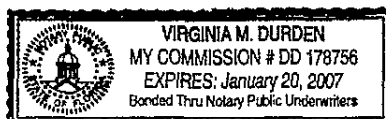


