ARTICLE I

The name of this corporation is JAYSONAMLE, INC. Its principal place of business is 3280 Tamiami Trail, Punta Gorda, FL 33952 and its mailing address is 99 Nesbit Street, Punta Gorda, FL 33950.

ARTICLE II

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.




