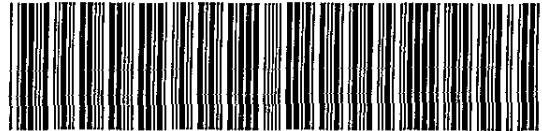

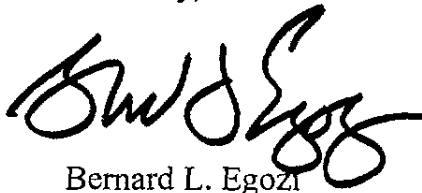

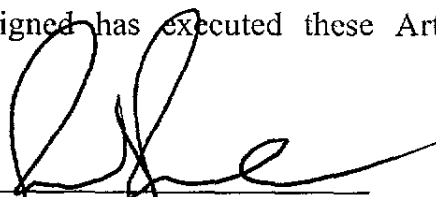
#### **ARTICLE VII - BYLAWS**

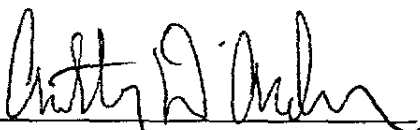
