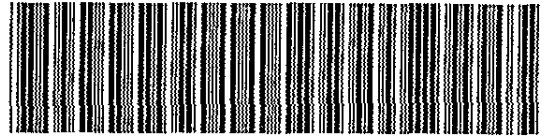



ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is ROBERT BEACH, INC.

ARTICLE II. PRINCIPAL OFFICE

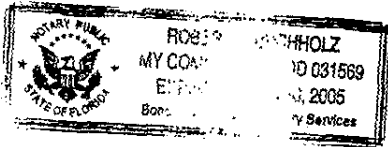

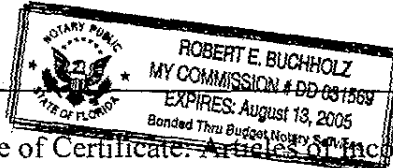
