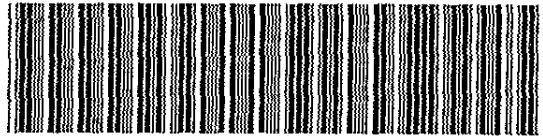

ARTICLES OF INCORPORATION OF

ARTICLE I

NAME

The name of the corporation is TEPPS PEMBROKE, INC.

DURATION AND COMMENCEMENT OF EXISTENCE

The corporation shall indemnify any officer or director, or former officer or director, to the full extent permitted by law.



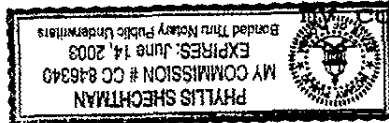
