ARTICLES OF INCORPORATION OF CENTRAL FLORIDA LAWN AND GARDEN, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is CENTRAL FLORIDA LAWN AND GARDEN, INC.

ARTICLE II - NATURE OF BUSINESS
