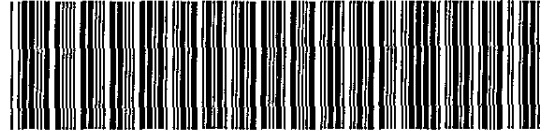

RICHARDSON, hereby certifies that on the 27th day of May, 2003, the Sole Director by proper corporate action with formal approval by the sole Shareholder, amended the Articles of Incorporation of FLORIDA NAVIGATIONAL CONSULTANTS, INC., as follows:
