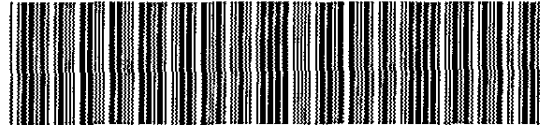

individual authorized to contract, hereby presents these Articles of Incorporation for the  
purpose of forming a corporation for profit under the provisions of Section 607, Florida  
Statutes.

**ARTICLE I**

**NAME AND PRINCIPAL OFFICE OF CORPORATION**

The name of the corporation is L. COURTNEY PLUMBING COMPANY, INC.

**ARTICLE II**

**PURPOSES**

This corporation is organized for the purpose of transacting any and all lawful

this Article XII may be modified by a separate written agreement between the corporation and the shareholder receiving shares in the initial issuance of stock of the corporation.

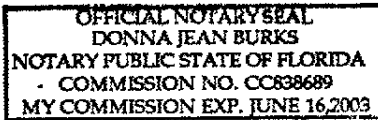
