


ARTICLE IX

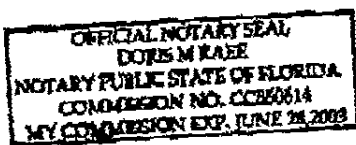
