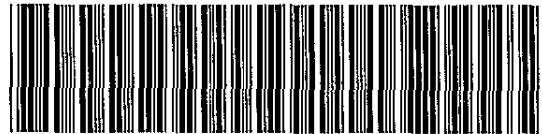

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE **SCHOLASTIC PREP ACADEMY, Inc.**

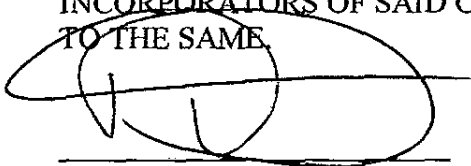
