ARTICLES OF INCORPORATION

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I.

The name and initial address of this Corporation shall be: Clearlake Plaza Executive Suites, Inc., c/o Karl Corporation, 500 Australian Avenue South, Suite 710, West Palm Beach, Florida 33401, with the privilege of having its offices and branch offices at other places within or without the State of Florida.
