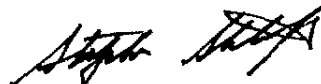

ARTICLES OF INCORPORATION
OF
JEREMIAH DEVELOPMENT CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be JEREMIAH DEVELOPMENT CORPORATION.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address is 5 Palm Lane, Ponte Vedra Beach, Florida 32082.

ARTICLE III - DURATION

The duration of the corporation is perpetual.

ARTICLE IV - PURPOSE

The general purposes for which the corporation is organized are the following:

(a) To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

(b) To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

(c) To acquire by purchase or lease, or otherwise, lands and interest in lands and to own, hold, improve, develop, subdivide, plat or to sell such real estate, as well as to manage any real estate so acquired, and to erect or cause to be erected on any lands owned, held or occupied by said corporation, buildings or other structures with their appurtenances, and to rebuild, enlarge, alter or improve any buildings or other structures now or in the future erected on any lands so owned, held or occupied, and to manage, sell, lease or otherwise dispose of any lands or buildings at any time owned or held by the corporation.

ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 5 Palm Lane, Ponte Vedra Beach, Florida, 32082, and the name of its initial registered agent at that address is JOHN K. JEREMIAH.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial Board of Directors is one (1). The number of directors may be increased or decreased from time to time in accordance with the By-Laws but shall never be less than one (1). The name and address of the initial director of the corporation is JOHN K. JEREMIAH, 5 Palm Lane, Ponte Vedra Beach, Florida 32082.

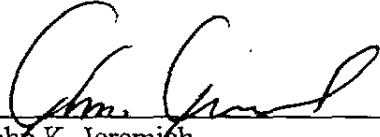
ARTICLE VIII - INCORPORATOR

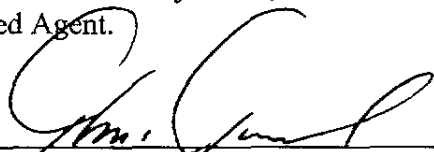
