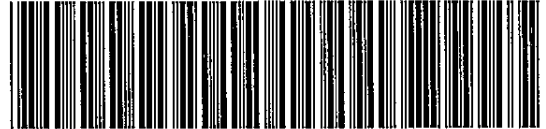

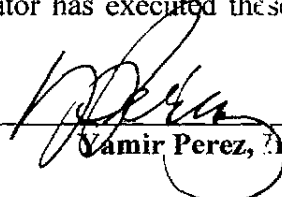
ARTICLE IX: INDEMNIFICATIONS

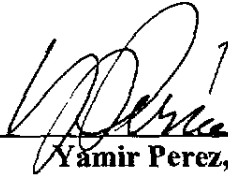
