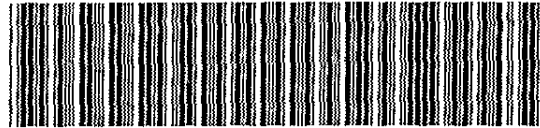

**ARTICLES OF INCORPORATION  
OF  
Downtown Mediation, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE ONE  
NAME & ADDRESS**

The name of the corporation is **Downtown Mediation, Inc.** Its principal place of business is at 319 Clematis Street, Suite 811, West Palm Beach, FL 33401.

**ARTICLE TWO  
CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE THREE  
PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

- 1 To perform all services relevant to civil litigation mediation and family mediation services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
