

ARTICLE I - NAME

The name of this Corporation shall be GOSPEL OPERATION TO SAVE LIVES, INC

ARTICLE II - DURATION

This Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation shall be to engage in any activities or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK




