Articles of Incorporation Of Custom Sheetrock, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be: Custom Sheetrock, Inc.

Article 2. Address. The mailing address and principal office of the Corporation is 5422 Mobile Drive, Seffner, Florida 33584.

Article 3. Authorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue one thousand (1000) common shares.

Article 4. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 11520 East Highway 92, Lot C4, Seffner, Florida 33584, and the name of its initial registered agent is Ryan J. Casale.

The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1).
