Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the Corporation is presently **EHC - SITE, INC.**
2. The following Amendment to the Articles of Incorporation was adopted by the Incorporator and Sole Director of the Corporation on April 15, 2012, in the manner prescribed by the Florida Business Corporation Act; the Amendment was adopted without shareholder action and shareholder action was not required.

3. Article I of the Articles of incorporation of **EHC - SITE, INC.** is hereby amended to read as follows:
