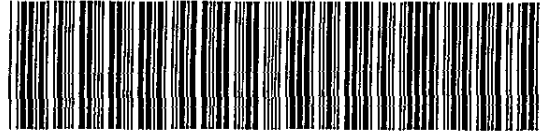

**ARTICLES OF INCORPORATION  
OF  
THE CLEANING CONNECTION OF SARASOTA, INC.**

**ARTICLE 1. - NAME**

The name of this corporation is **THE CLEANING CONNECTION OF SARASOTA, INC.**

**ARTICLE 2. - DURATION**

This corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE 3. - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE 4. - POWERS**

This corporation shall have all of the powers enumerated in the Florida General Corporation Act.

**ARTICLE 5. - CAPITAL STOCK**

This corporation is authorized to issue 7,500 shares of voting common stock with a par value of \$1.00 per share.

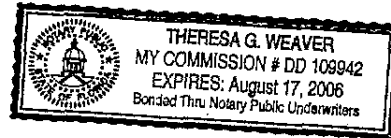
