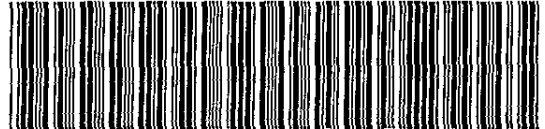

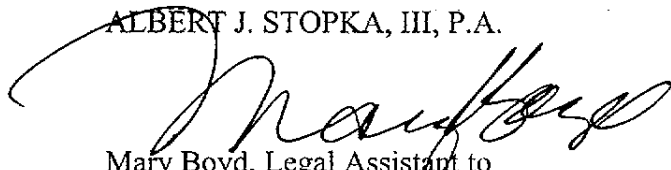

The undersigned, acting as incorporator of a Corporation under
the Florida General Corporation Act, adopts the following Articles
of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is FOOTPRINTS IN THE SAND, INC.,
and the street address of the initial principal office is 1805

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting
any or all lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue one hundred (100)
shares of One Dollar (\$1.00) par value of common stock, which shall

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE VII - TERM OF EXISTENCE

This corporation is to exist perpetually.

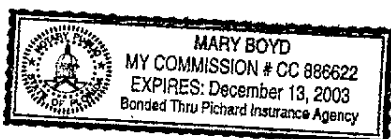
