Articles of Incorporation of Dreamy Creamy Creations, Inc.

The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

Article 1. The name of the corporation is Dreamy Creamy Creations, Inc. The principal office location is 11116 NW 60th Terrace, Alachua, Florida 32615.
