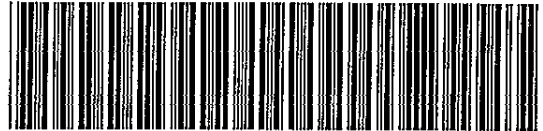


ARTICLE FOURTEEN – PREEMPTIVE RIGHTS

ARTICLE FIFTEEN - EFFECTIVE DATE


