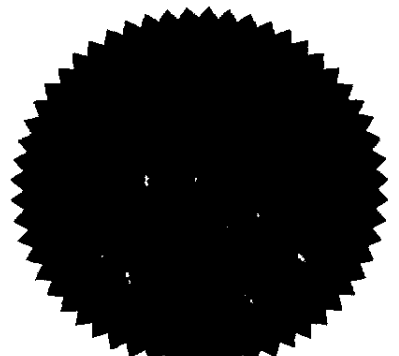

The name of this corporation is: Rotran Simulator Logistics, Inc.

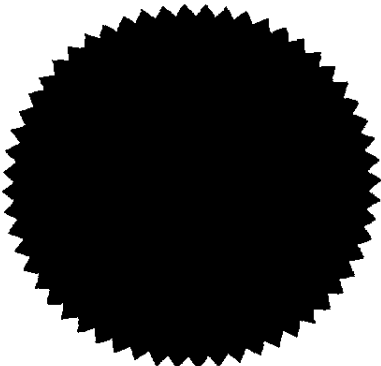
