ARTICLES OF INCORPORATION

OF

NOWAKOWSKI'S FOODS, INC.



The undersigned, acting as incorporator of a corporation (hereinafter referred to as the "Corporation") under the provisions of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I NAME
