**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is J.J. International Trading Corporation, Inc. Its principal office address and business mailing address is 5775 W 20 Avenue, Ste 308, Hialeah, Florida 33012-7556.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**
