CORPORATE NAME**

The name of the corporation shall be:



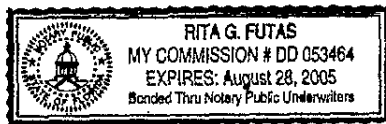
