The undersigned subscribe to these Articles of First International Financial Corporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I- NAME

The name of this corporation is First International Financial Corporation.

ARTICLE II- NATURE OF BUSINESS
