**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**CORPORATE NAME AND PRINCIPAL OFFICE**

The name of this corporation is NTSI OF NEW ENGLAND, INC. and its principal office and mailing address is 2005 Pan Am Circle Drive, Suite 1000, Tampa, Florida 33607.

**ARTICLE II**

**COMMENCEMENT OF CORPORATE EXISTENCE**

The Corporation shall come into existence on the date of subscription and acknowledgment of the Articles of Incorporation.

**ARTICLE III**

**GENERAL NATURE OF BUSINESS**

The Corporation may transact any lawful business for which corporations may be incorporated under Florida law.

**ARTICLE IV**

**CAPITAL STOCK**

The aggregate number of shares of stock authorized to be issued by this corporation shall be 1,000 shares of common stock, each with a par value of \$1.00.
