#### ARTICLES OF INCORPORATION

#### CHARLES MATERIALS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation is CHARLES MATERIALS, INC.
