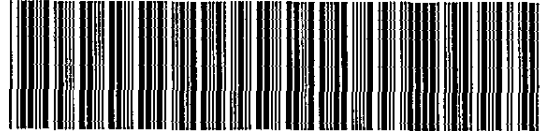

ARTICLE II - REGISTERED OFFICE AND AGENT
