ARTICLES OF INCORPORATION OF IMPULSE GIFTS, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is IMPULSE GIFTS, INC., and the principal address and principal place of business is 2253 WEST BAY ISLE DRIVE SE, ST. PETERSBURG, FLORIDA 33705.

ARTICLE II - REGISTERED OFFICE AND AGENT
