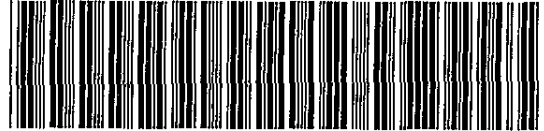

ARTICLES OF INCORPORATION

OF

STOP & SHOP MEAT MARKET INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is:

STOP & SHOP MEAT MARKET INC.

ARTICLE II

The following persons shall be the officers of this Corporation for the first year of its existence or until their successors are elected and have qualified:


